Summary:

On Wednesday, November 10, 2021, at approximately 8:30 am, San Mateo County Sheriff's Office Deputies from the San Carlos Police Bureau Deputies located a vehicle wanted for a grand theft from the CVS Store in San Carlos in the parking lot of a business on the 900 Block of El Camino Real in San Carlos. Deputies observed three female subjects standing/sitting in and around the vehicle as well as in a nearby hotel room. Deputies contacted Dwyer, Bund, and Apodaca at the vehicle and in a nearby hotel room. All subjects were detained as part of the grand theft investigation. A records check of Dwyer revealed a warrant for her arrest. A records check of Bund revealed a warrant for her arrest as well. While attempting to place Bund under arrest, she fled on foot but was quickly apprehended.

Deputies located illegal narcotics inside the hotel room in plain view. Apodaca admitted possession of the illegal narcotics and was placed under arrest. Deputies also located numerous items that could be associated with fraudulent activities. The vehicle was seized for evidence and later searched for evidence after Deputies obtained a search warrant. Deputies were able to locate evidence in the vehicle connecting the three female suspects to the theft from the night prior. All suspects were arrested for the theft and conspiracy stemming from the events from the night prior, as well as their on-view charges. All suspects were booked into the San Mateo County Jail.
