Summary:

On 11/04/2021, at approximately 10:28 a.m., an armed robbery occurred at Crystal Springs Golf Course in unincorporated San Mateo County. Two suspects robbed the victim at gunpoint, using a Glock semiautomatic pistol with a high capacity magazine. They stole the victim's Rolex watch and wallet before fleeing in a silver Infiniti Sedan. Approximately one hour later, the same suspects committed another robbery in the City of San Ramon.

Soon after the second robbery, Alameda County Sheriff's Deputies located the suspect vehicle in the Stoneridge Mall parking lot in Pleasanton. Alameda County Sheriff's Deputies attempted to contact both suspects who immediately fled on foot. One suspect identified as Fajon Green was apprehended while his co-conspirator was able to evade Deputies.

Green was in possession of the Glock pistol and several Rolex watches. San Mateo County Sheriff's Office Detectives took custody of Green and brought him back to the Sheriff's Office where he was interviewed. During the interview, Detectives later learned that he and his co-



conspirator also committed an armed robbery in San Mateo on November 3, 2021 using the same firearm.

Green was later placed under arrest and booked at the San Mateo County Jail without incident.

Sheriff's Office Detectives are currently working with the Daly City, San Mateo, and San Ramon Police Departments with this ongoing investigation.
